Community Fund Grants \$200,070 and Donor Option Funds \$188,027 26 local programs at 14 local non-profit agencies were supported by grants through a competitive grant process of proposal and presentation to 40 volunteers from our community that made the final decisions. Donor Option Funds include donations designated by our donors to specific non-profits of their choice. Recruitment, training and support of the volunteers for the review process as well as training, accountability, and oversight of agencies receiving funds are important parts of making sure donations have the MOST impact in our community.

Community Building Activities: UWENM builds capacity within the community by encouraging and supporting greater volunteerism through our Volunteer Action Center: training agencies, marketing local volunteer opportunities, celebrating company and individual volunteerism (\$43,931). UWENM staff and over 140 volunteers brought "Reality Check Day" of adult financial responsibility to over 140 high school freshmen in both counties and 6 school districts (\$15,550). In addition to these projects, UWENM also hosted the area's first ever Veterans Resource event, held professional trainings on non-profit development for the community, hosted monthly food distribution in Portales providing 45+ pounds of groceries for 265 families, and supported activities of coalitions such as Ministerial

2-1-1 Information Helpline assisted 1593 callers in 2016, referring them to local/regional services (\$32,300). 2-1-1 compiled & published the Summer Activity Guide -a FREE directory of activities for children and families- distributing 10,000 copies across Curry & Roosevelt Counties (\$2,439). 2-1-1 provided direct relief from winter cold and summer heat with heaters and fans to 35 households. 2-1-1 intervened to prevent homelessness for 131 households who were facing eviction and utility cutoff. 2-1-1 helped 147 people take steps toward financial stability by paying the fees for ID cards, Birth certificates, and drivers licenses-required to find jobs and housing (\$40,680). 2-1-1 gathered over 15,000 diapers to provide to local diaper banks and over 6,500 school supplies for local teachers.
